The governance structure put in place for HERE is designed to secure the company's long-term strategy to become the leading location cloud platform serving multiple industries. The new Supervisory Board will oversee the executive leadership team of HERE, led by CEO Edzard Overbeek. The Chairman for the Supervisory Board is planned to be appointed during the coming weeks.

Rudi Lamprecht said: "HERE has a tremendous opportunity to shape the future of mobility for the better and I am thrilled to be able to offer my support in that effort. In particular, I believe HERE has a key role to play in autonomous driving on a global scale, and the company's strong financial position enables it to accelerate its investment in this opportunity."
